Conditions of Tender

1. Upon acceptance of tender, payment by Direct Credit or Bank Cheque is required to be deposited into the nominated bank account (ASB Bank, Auckland Central, A/c No 12-3109-0065311-00, Auckland Trotting Club 2012 Syndicate) within two (2) working days of receiving acceptance of tender.
2. The Auckland Trotting Club 2012 Syndicate is registered for GST and your tender bid is to be plus GST. The Auckland Trotting Club 2012 Syndicate will provide a GST Tax Invoice for the sale of the horse.
3. If the horse is to be exported from New Zealand within 28 days, there is no GST payable and subject to the purchaser providing guarantee of export, the price if so stated will reflect this clause.
4. The horse can be inspected by appointment, by contacting Mr Rob Carr, Mobile 64 21 227 6444 or Email rob.carr@xtra.co.nz
5. Every tender shall be a continuing offer and shall be irrevocable until the 3rd March 2017. Any tender not accepted on or before that date shall lapse.
6. The vendor may accept any tender by posting or emailing a notice of acceptance, addressing the successful tenderer as 'the purchaser' at the address provided within their tender.
7. Upon receiving the purchase money from the purchaser, the vendor is to execute all documents necessary to transfer the horse to the purchaser. The vendor is to enable the purchaser to have the horse registered in their name and is to give delivery of the horse to the purchaser at the property at 18 Sands Road, Waiuku, Auckland, New Zealand.
8. If the purchaser fails to meet the agreed payment date with the agreed amount of money or fails to observe or perform any of the agreements or conditions in these presents contained or implied (time being deemed strictly of the essence of this contract), the vendor may, without notifying the defaulting purchaser, resell the horse as they see fit whether as to time or mode of payment of the purchase money or otherwise. The purchaser is liable for any deficiency or loss (if any) occasioned by such resale including all outgoings relating to the horse and interest at the rate of 18 percent per annum from the due date for payment as above of the overdue balance of the purchase money down to the date of the completion of such resale and all charges attending such resale and every attempted resale.
9. The description of the horse set out on Page 1 of this document shall be deemed to be correct. No warranty of any kind is to be implied or given by the vendor as to the value, quality or condition for any particular purpose of the horse. No error or misdirection which may exit in the schedule shall cancel the sale under these conditions, not shall any compensation be payable by the vendor for any such error or misdirection should any such be found.
10. Upon the acceptance of any tender the horse shall, as from the date of such acceptance, become the sole risk of the purchaser as regards injury, theft, or uncontrollable event considered 'Force Majeure'. The purchaser shall not be entitled to delivery of the horse, nor shall the purchaser acquire any property in the horse, until full payment of the purchase money is received by the vendor.
