Candidate Profiles and Photos

Each candidate must provide a candidate profile statement and a passport type photo with their nomination paper. These profiles will be published by the Returning Officer in a candidate sheet which will be distributed with the voting documents. Profile statements should be provided electronically in a Microsoft Word document. Profile statements should not exceed 450 words, excluding the candidates name. The word limit will be strictly enforced. Photos must also be provided electronically (scanned as a .jpeg at 300 dpi). The photos may be formatted by the Returning Officer to ensure standardisation between candidates. Photos must be a head and shoulders shot of the candidate only, with no hats, sunglasses, pets, objects or other people visible. Photos should be recent, ideally no older than 6 months. The Returning Officer and ATC are not required to verify or investigate any information included in a candidate profile statement. The Returning Officer and ATC will take no responsibility for the accuracy of the content, however, may suggest corrections to spelling or grammar if appropriate. A disclaimer concerning the accuracy of the information contained in the statements will be included on the profile statement sheet that accompanies the voting documents and on the website, respectively.
